

DATA PROTECTION

We appreciate your interest in our company and our products, and we want you to feel secure about the protection of your personal data.

The use of our website is usually possible without providing personal data. To the extent personal data (e.g. name, address or email address) are collected on our website, this is always done on a voluntary basis, if possible. This data will not be passed on to third parties without your express consent. Please note that data transmission over the Internet (e.g. when communicating by email) may have security vulnerabilities. You cannot completely protect data against access by third parties. We expressly oppose the use of contact details published under the legal obligation of third parties to send unsolicited advertising and information material.

Below you will find detailed information regarding the handling of personal data belonging to you. Personal data is all data that relates to your person, e.g. name, address, e-mail addresses, user behavior.

1. Information on the collection of personal data

1.1 The responsible entity within the meaning of art. 4 clause 7 of the General EU Data Protection Regulation (GDPR) is Böggershausen Consulting SRL Consulting + Management; Romania, Bucuresti, Sector 6, Str. Iuliu Maniu, Nr. 99, Managing Director: Jens Böggershausen. In matters related to the processing and protection of personal data, a contact point has been designated in the form of an e-mail address: jb@b-construction.info. 1.2 In case of that you contact us via e-mail, the data provided by you (e-mail address and name, and possibly other information voluntarily provided) will be stored by us in order to answer your questions. The data collected in this context is deleted when a record is no longer required, or we limit processing if there are legal storage obligations.

2. Your rights

2.1 You have the following rights with regard to us regarding your personal data:

- Right to information,
- Right to rectification or deletion,
- Right to restriction of processing,
- Right to object to processing,
- Right to move data.

2.2 In addition, you have the right to lodge a complaint regarding our processing of your personal data with the data protection supervisory authority.

3. Collection of personal data when visiting our website

3.1 In the case of informative use of the website, i.e. if you do not register or provide us with any information, we only collect personal data sent by your browser to our server. If you want to browse our website, we collect the following information that is technically necessary for us to be able to display our website to you, as well as ensure stability and security (the legal basis is Article 6 para. 1 sentence 1 letter f GDPR):

- IP Address
- Date and time of inquiry
- The time zone difference from Greenwich Mean Time (GMT)
- Content requested (specific page)
- Access status / HTTP status code
- Each amount of data transferred
- The page from which the request originated
- Internet search engine
- Operating system and its interface
- Language and version of the browser software.

3.2 In addition to the data mentioned above, cookies are also stored on your computer when you use our website. Cookies are small text files that are stored on your hard drive, assigned to the browser you use, so that the unit that sets the cookie (in this case us) receives certain information. Cookies cannot run programs or transfer viruses to your computer. They are used to create an Internet offer, which in its entirety will be more user-friendly and more effective.

3.3 Use of cookies:

3.3.1 This site uses the following types of cookies, the scope and operation of which are explained below:

- *Transient cookies* (look: 3.3.2)
- *Persistent cookies* (look: 3.3.3)

3.3.2 Temporary cookies are automatically deleted when you close your browser. These include especially session cookies. They record so-called Session ID, with which you can assign different browser queries to a shared session. Thanks to them, you can recognize your computer when you return to our website. Session cookies are deleted when you log out and close the browser.

3.3.3 Persistent cookies are deleted automatically after a specified period of time, which may vary depending on the type of cookies. You can delete these cookies at any time through the security settings of your browser.

3.3.4 You can configure your browser settings according to your wishes, e.g. refuse to accept third-party cookies or all cookies. We would like to remind you that you will not be able to use all the functions of this website.
